BREEDER <u>STEPHANIE TELLIER</u> guarantees this puppy to be in good health at the time of sale. The puppy will come with a shot record stating which vaccinations have been given.

\*\*\* At the time of sale this puppy is considered to be "Pet Quality" and the breeder offers no guarantee of size, color, showing or breeding ability. Breeder further guarantees this puppy for 12 months (from date of birth) against life threatening congenital defects (which means he/she will die from the genetic defect).

\*\*\* In order for the life threatening genetic health guarantee to be valid, the buyer agrees to take the Puppy/Adult to a veterinarian within 2 business days of the date of purchase for a physical examination to evaluate the health of the puppy at the time of sale. Failure to notify the BREEDER by either email or phone of the veterinarian's report within 2 business days from the examination will void and nullify all health guarantees.

\*\*\* Should the puppy be found to have a LIFE THREATENING GENETIC DEFECT within this time period, a written copy of the report must be emailed to us within 2 business days of the licensed veterinarian determination and have one written report from an unassociated veterinarian stating the same problem and the BREEDER will provide a replacement puppy of comparable quality, same color, same sex. If the BUYER chooses to return the puppy, the puppy will be returned along with all registration papers and all documents that came with the puppy at time of purchase, at the BUYER'S expense.

\*\*\* If a puppy is being returned to the BREEDER, the returned puppy must be returned in a good healthy condition, other than the specified problem, at the BUYER'S expense, the puppy will be returned along with all registration papers and all documents that came with the puppy at time of purchase, at the BUYER's expense. The puppy needs to be returned within 1 week. The BUYER will then qualify for a replacement puppy. \*\*\* No replacement puppy will be given if the puppy has been euthanized without the permission of the BREEDER, before a consultation with the treating veterinarian. The exception to euthanasia would be in the case of severe injury or suffering on the part of the animal.

\*\*\* The BREEDER is not responsible for any medical expenses incurred. At no point will money be refunded. This guarantee does not cover uneven bites, cherry eye, deafness, hernia, ear mites, mange, cancer, thyroid dysfunction, heart murmur, tumors, kennel cough, autoimmune disorder, external parasites, stenotic nares (collapsed/pinched nostrils), entropion, elongated soft palate, undescended testicles, allergies, GIARDIA or COCCIDIA, diarrhea or worms, luxating patella, which can be common to the Boston Terrier Breed. \*\*\* We DO NOT guarantee against conditions that may or may not be stress related from the move to a new home and/or by the shipping process. The stress-related conditions that have previously remained dormant can be triggered by the above and unfortunately cannot be diagnosed until an active case becomes evident. Some of these stress-related conditions or illnesses are Coccidia, Kennel Cough, and Hypoglycemia (low blood sugar). \*\*\* BREEDER will never be responsible for PARVO, DISTEMPER or CORONAVIRUS after leaving our care, those are highly contagious illnesses and we suggest you limit the number of places you take your puppy and never take your puppy outside until he/she has had all their Vaccinations ! Some of these parasites are not detectable and can even be brought on by stress, but most of these parasites can be cured with a few rounds of medicine. \*\*\* Under no circumstances will the BREEDER ever be responsible for BUYER'S veterinary bills, medical care or any return shipping expenses associated with this puppy. It is YOUR responsibility as a pet owner to take care of your pet the same as you would your own child. THE BREEDER ONLY COVERS LIFE THREATENING GENETIC ILLNESS.

\*\*\*Adjustment Period: The puppy will need 2-4 weeks to adjust to its new home, people, change of food, etc. It is not abnormal for the puppy to experience some mild vomiting and/or diarrhea.

A note on health testing in the canine world:

\*\*\* JHC test for cataracts does not prevent age related cataracts. There are patella tests but does not prevent age related joint issues later in life. There are cardio tests, but does it prevent age-related heart issues later in life.

\*\*\* Even with BAER testing (for hearing), it does not test for the actual gene that causes deafness, which also can come later in life, age related, and/or occur in future offspring. We also take for granted that these tests guarantee the health of our dogs for life when in fact they do not.

We are 100% TESTING for what people realize is NOT a lifetime guarantee. Humans age as well as our bodies and even our minds. When you buy health tested dogs, remember that testing as wonderful as it is does not (in itself) guarantee for a long healthy life, it is the responsibility of you the owner to make that happen by being a responsible fur parent.

The SELLER has the right to contact and verify from the BUYERS veterinarian for proof of the Spay/Neuter . The BUYER may NOT register this puppy with any other registry other than AKC. If the BUYER breeds and/or registers this puppy with another registry other than American Kennel Club, BUYER breaches this contract and BUYER will voluntarily pay the SELLER \$10,000.00 U.S. Dollars in damages upon demand by the SELLER , BUYER shall also pay all court costs associated with this matter .
